From the Desk of Russ Jones, President, Arizona Heritage Alliance

Together, over the past decade, we helped return the State Parks Heritage Fund to its rightful place to benefit Arizona. With thousands of community allies and dozens of legislative champions, most notably State Senators Kate Brophy McGee and T.J. Shope and Representative Joanne Osborne, the State Parks Heritage Fund was put back into statute (2019) and \$5 million was appropriated (2021).

Through a matching grant process developed by State Parks Board, State Parks staff, and SHPO staff, FY 2021-2022 monies in the State Parks Heritage Fund have been and continue to be allocated as follows:

- 50% (\$2.5 million) for local, regional, and state parks for outdoor recreation and open space development, restoration, or renovation,
- 30% (\$1.5 million) for local, regional, and state historic preservation,
- 10% (\$500,000) for local, regional, and state non-motorized trails, and
- 10% (\$500,000) for outdoor/ environmental education

In January 2022, Senator Shope sponsored Senate Bill 1270 to fund the State Parks Heritage Fund through the Arizona Lottery (the original source of funding). The bill passed both the Senate and House Appropriation Committees and after several months of waiting, the Governor has signed the budget and approved a one-time appropriation in the amount of \$2.5 million for the Arizona State Parks Heritage Fund for 2022/2023. Although this is only half of the \$5 million that was proposed, we are please the Heritage Fund is funded again for FY 22/23.

As part of our ongoing support for the State Parks Heritage Fund, a huge congratulations to the FY

Heritage Fund is HALF Full!

While the Arizona State Parks Heritage Fund appropriations was cut in half from \$5 million last fiscal

year (21/22) to \$2.5 million this fiscal year (22/23), the State Legislature and Governor approved other significant funding for parks, trails, historic preservation, and wildlife conservation. Over and above funding for the staffing and operations of Arizona Game & Fish and Arizona State Parks & Trails (the two state

<u>Fish</u> and <u>Arizona State Parks & Trails</u> (the two state agencies that the <u>Arizona Heritage Alliance</u> advocates for every day), investments were made for the following initiatives:



- Historic Resources: Arizona Historical Society;
 Arizona Mining, Mineral & National Resources Museum; Arizona Pioneers' Home; Fort Whipple
 Homeless Veterans Housing; Prescott Historical Society; State Capitol Renovations; historic
 building renovations at Jerome State Historic Park, Tombstone Courthouse State Historic Park, and
 Tonto Natural Bridge State Park; Arizona Dude Ranch Registry; and State Archives Born Digital
 Record Preservation Study.
- Natural Resources: Arizona Trail; campground, solar shade, smartphone accessibility, and water
 conservation projects at state parks statewide; specific improvements at Catalina State Park,

Dead norse State Park, and Rockin River Ranch State Park; and mitigation of drought conditions affecting wildlife and sportsfish.

In addition, the Alliance has always supported the leveraging of funds from the federal <u>Land and Water Conservation Fund</u> (LWCF) with all related grant programs managed by state and local governments. The Alliance applauds the recent announcement by the U.S. Department of the Interior that \$5,695,464 from the LWCF will be invested in Arizona for outdoor recreation and conservation efforts, strengthening public lands and waters, building new outdoor spaces, and expanding access to outdoor recreation.

The Alliance thanks the thousands of Arizonans who called, wrote, emailed, texted, and used the Legislature's Request to Speak service this past legislative session to voice their support of the State Parks Heritage Fund and Arizona's historic and natural resources overall.

Alliance News & Notes

In a poll dated February 22, 2022 Arizona Statewide Issues, 7-in-10 voters (70%) support restoring the Arizona State Parks Heritage Fund. The poll was conducted by <u>TargetSmart</u> for the <u>State Innovation</u> <u>Exchange</u>. You can access the full report on the Alliance's <u>website</u>.

The Colorado College released the results from their 2022 Conservation in the West poll which includes

responses on the benefits of public lands spaces to Arizonans. Polling in eight western states explored voters' bi-partisan opinions in each state and of the Rocky Mountain West. The survey polled registered voters in Arizona, Colorado, Idaho, Montana, Nevada, New Mexico, Utah and Wyoming. Voters responded to questions concerning conservation public lands, energy, water, wildlife, wildfire, and other pressing challenges in the Mountain West. Here is a link to the <u>full report</u>. Thank you to Sierra Club - Grand Canyon (Arizona) Chapter for coordinating today's Environmental Day at the Capitol and a huge shout out to Sandy Bahr for tireless work to make this event happen for all of us. We were fortunate enough to be one of the supporting organizations this year. We shared information about

the Heritage Alliance and the Arizona



Heritage Fund. We had a table with our collateral including information on SB1270 and were asked to briefly introduce ourselves during the opening. Various individuals coordinated meetings with their District Legislators.

The <u>Arizona Game and Fish Department</u> is pleased to announce a grant designed specifically for Arizona educators. The goal of this program is to provide financial resources (up to \$2000) to Arizona teachers to help implement quality wildlife education in their classrooms. Any education professional who is currently operating within the state of Arizona is eligible to apply. This includes



government and non-profit employees who are responsible for educating Arizona's students. However, preference will be given to current K-12 district and charter school teachers. We are currently seeking grant proposals where the applicant:



- Has attended a previous educator workshop hosted by the Department (or has plans to attend a future workshop) and wants some money to help implement education related to that workshop. OR
- Is currently partnering with the Department on a project directly benefiting Arizona students and needs some money to assist with this project. OR
- Has developed a unique, inquiry-based field trip to take place on one of the many public lands in Arizona and needs money to off-set some of those costs.

We will begin accepting applications in July and they will be due by Sept 1. Any applications received after that deadline may be eligible for an additional scoring round in January and May, if money is available. At the June 16, 2022 Arizona State Parks & Trails Board Meeting, Mickey Rogers, Chief Grants & Trails,

provided an update of the total amount of the grants approved through State Parks and the Arizona State Historic Preservation Office - SHPO for fiscal year 2021/2022. The following chart shows the amount of the grant award, the match and the TOTAL amount awarded for the project. Over \$23,099,289 grants were awarded with a total match of \$22,628,426 for a total invested in projects across the state being **\$45,727,716.** Huge shout out the State Parks and SHPO staff for making this happen and thank you State Parks Board for your leadership and supporting these much needed projects.

Partner Spotlight: Vail Preservation Society

The Vail Preservation Society (VPS) began in late 2006 as a community action group to preserve the Old Vail Store & Post Office. In September 2007, the IRS recognized VPS as a 501(c) 3, non-profit organization. VPS participates in research, education, preservation of local stories through oral histories, saving and repurposing historic buildings, and outreach events that celebrate the history of Vail and honor its railroad and ranching roots.

VPS serves the greater Vail community, a largely rural area located southeast of Tucson. The organizaation's focus area of interest closely mirrors the Vail Unified School District borders: from the southern boundary of Saguaro National Park East south to the Santa Cruz County line, and from the Cochise County line west to Wilmot Road.



VPS supports the historic preservation and education efforts of other regional organizations like the Vail Unified School District, Southern Arizona Transportation Museum, Santa Rita Foothills Association, Empire-Fagin Coalition, Postal History Foundation, Tucson Historic Preservation Foundation, Vail Community Action Board, Tucson Rodeo Parade Museum, Empire Ranch Foundation, Cienega Watershed Partnership and Santa Cruz Heritage Alliance.
